
License Grant




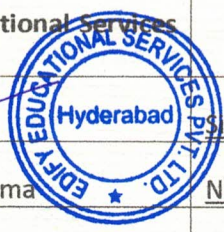
