General Suggestions:

- 1. As we have developed our MBA curriculum as per UGC and AICTE guidelines, the university nominee and external Board of Studies members accepted the same.
- 2. Dr. A. Krishna Mohan, Professor of MBA Department in the JNTUK, discussed on evaluation modalities of internal & external examinations, entrepreneurial project assessments and its weightage. He also suggested that the simultaneous implementation of the Entrepreneurship Development course and the Main Project places considerable academic pressure on the students.
- 3. Dr. M.S. Narayana, Professor in the MBA Department at KL University, suggested introducing an Artificial Intelligence (AI) course as an elective in the MBA curriculum. He also emphasized that AI is rapidly transforming business functions such as marketing, finance, operations, and human resource management through automation, predictive analytics, and intelligent decisionmaking systems.
- 4. Dr. B. Nagaraju, Professor and Head of the HRM Department at ANU University, Guntur, suggested that Employment Welfare subjects be formally incorporated into the MBA syllabus, particularly within the Human Resource Management (HRM) stream. The inclusion of such subjects would provide students with a comprehensive understanding of labour laws, employee benefits, social security measures, and organizational welfare practices.
- 5. The introduction of these topics would not only align the curriculum with current industry needs and legal frameworks but also prepare students to handle employee relations and welfare responsibilities effectively in real-world HR roles.
- 6. Mr. C.V. Satyanarayana Reddy, Managing Partner at Vidhata Pharma Services, Hyderabad, suggested the integration of technology-driven courses in the MBA curriculum. He highlighted the significance of emerging technologies such as Business Analytics, Artificial Intelligence, Digital Marketing, Enterprise Resource Planning (ERP), and Financial Technology (Fin Tech) in transforming traditional business models.
- 7. He also advocated for collaborations with industry partners to co-develop content, offer guest lectures, and facilitate live projects that reflect current market needs and innovations. His suggestions aimed to make the MBA programme more dynamic, industry-relevant, and future-
- 8. Mr. Ch. Ramachandra Reddy, Team Lead Operations at Accenture, Hyderabad, He suggested that MBA students should be regularly taken on industry visits to observe operational processes, understand corporate culture, and gain practical insights into business functions such as supply chain management, human resource practices, customer service, and technology integration.

Based on the suggestions provided by the subject& industry experts, and other members of the body, the Chairman of the MBA Board of Studies, Mrs. D. Mary Sharmila Rani, decided to implement the course structure and syllabus pending approval from the Academic Council at its meeting.

The meeting ended with a vote of thanks proposed by Mrs. D. Mary Sharmila Rani, the chairman of the MBA-Board of Studies.
